## INTRODUCTION

ORCC is a charity that works with and supports communities across the county and has long-standing expertise in helping communities with consultation strategies.

Berinsfield Parish Council is currently preparing a Neighbourhood Development Plan (NDP). As part of its evidence gathering process, the NDP Team commissioned Oxfordshire Rural Community Council to conduct a community survey in October 2014.

The survey gave all households in the village the opportunity to express an opinion on the future development of housing, infrastructure and services in Berinsfield.

## DISTRIBUTION AND RESPONSE

- ORCC, liaising with the NDP Team, prepared the survey content.
- The NDP Team distributed surveys to 1150 households in November 2014.
- 227 surveys were returned in a *Freepost* envelope to ORCC: **a response rate of 20%**.
- ORCC analysed the returned surveys and prepared this report.
- No information is known about households which did not complete a survey, and no assumptions have been made about their opinions, needs, or requirements.

## SUMMARY OF FINDINGS

The report gives a detailed breakdown of answers to all survey questions. The following is a selection of findings.

---

**67%** of households believe **109 new homes or more** (consistent with the District Council's Core Strategy 2027) is the most suitable development option for Berinsfield

**54%** of households believe that some areas in the village need regenerating but most **development should go OUTSIDE the current developed area**

**Top 5** sites that should be included in the Neighbourhood Development Plan (NDP) as possible development sites:

- 1- BER13
- 2- BER18
- 3- BER1
- 4- BER23
- 5- BER4

**Top 5** sites that should be protected from development in the NDP:

- 1- BER17
- 2- BER16
- 3- BER9
- 4- BER7
- 5- BER14

**Top 2** preferences for the most needed type of housing:

- 1- Medium house- 2-3 bedrooms (60%)
- 2- Bungalows (35%)

**Top 2** preferences for housing tenure:

- 1- Owner-occupied homes (60%)
- 2- Sheltered Housing for older people - could be an Extra-Care Home (46%)

**Top 2** development planning preferences:

- 1- A number of smaller developments (74%)
- 2- Infill development (47%)

**Top 5** preferences for housing mix in new developments:

- 1- Two-storey (68%)
- 2- Retirement homes (53%)
- 3- Larger plots with off-road parking (53%)
- 4- Single-storey (31%)
- 5- Smaller-style houses (29%)


**Top 5** first choice preferences for improvements to community facilities:


### 1. How many people of each age group live in your household?

- 223 households – 562 individuals




### 2. Do you...?

- 224 households – 419 total selections





- ORCC emailed a copy of the Scoping Report to **38 households** who requested it




**4. Please tick the housing development option you think most suitable?**

- 216 households




**If you think more homes are needed, how many do you think Berinsfield requires?**









**7. What type of housing do you think is most needed in Berinsfield? Please tick your TOP TWO priorities.**

- 208 households – 425 total choices




**8. Please tick your TOP TWO priorities for the type of housing you think Berinsfield should plan for.**

- 216 – 430 total choices




**9. When planning for new developments, what would you prefer?**

**10. What mix of housing would you most like to see included in the new housing developments? Please tick all that apply.**




