8. **Correspondence and items for information.**

a) **Request by South Oxfordshire District Council to use the Parish Council's crest.** South Oxfordshire District Council's Garden Village Team have asked if it would be possible for them to have a copy of the Parish Council's crest as they may wish to consider using it in the new Garden Village logo. The Parish Council is asked if it would be in agreement with this request.

b) **Civil Parking Enforcement.** At the Parish Council meeting held on 4th October, 2021, Councillor Chrisp agreed to prepare a report on areas in Berinsfield that might benefit from having parking restrictions imposed on them. The Parish Council is asked to note that any suggestions would have to be passed to Oxfordshire County Council and that there would be no guarantee that they would impose the restrictions without an agreement that funding would be made available by the Parish Council.

c) **Clock on the Church of St. Mary and St. Berin** The Parish Council owns the clock that is on the front of the Church of St. Mary and St. Berin and permission was granted for it to be installed on the Church subject to all costs being paid by the Parish Council. Recently the glass covering over the clock has become misted and the manufacturers of the clock attended last week, removed the cover, cleaned it and replaced it. They have submitted a report to say that they recommend that a new cover glass should be manufactured and installed and the cost for this would be £1938.00. The Parish Council is asked to consider the recommendation made by the manufacturers.

d) **Request to use the recreation ground on 6th August 2022.** The Manager of the Berinsfield Information and Volunteer Centre has asked if the Parish Council would allow a music event to be held on the recreation ground on 6th August, 2022, subject to the relevant licences etc. being obtained. The purpose of the event would be to generate funds for the Berinsfield Information and Volunteer Centre.
