8. **Casual Vacancy on Berinsfield Parish Council.** To consider applications from eligible persons who wish to be considered for co-option as a Member of Berinsfield Parish Council.

To be eligible to be considered as a Member of the Parish Council persons should be over 18 years of age and should be on the Register of Electors. Persons over 18 years of age and on the Register of Electors, but who do not live in the village, may be eligible to be considered if they have resided in the locality or within three miles of it or occupied as owner or tenant any land or premises therein or had a principal or only place of work in Berinsfield. Such work need not be paid, but must be substantial.

 - a) **Queen's Platinum Jubilee.** Two flowering Cherry Trees have now been planted near to the adult gym equipment on the recreation ground. There are no seats in this area and the Parish Council is asked to consider whether the area by the flowering Cherry Trees would be an appropriate place to install a seat with a plaque to commemorate the Queen's Platinum Jubilee.
