## 8. Berinsfield Garden Village Grant Scheme

**a**) The Parish Council has now been informed that it has been awarded the following grants from the Berinsfield Garden Village Grant Scheme :-

Revenue Grant	Total £7,000	To prepare the Berinsfield Neighbourhood Development plan.
Capital Grant	Total £34,518	To construct a new path and install drainage in the Burial Ground. The Parish Council did apply for funding to construct a composting toilet and storage facilities, but this was removed from the application by South Oxfordshire District Council.

b) **Construction of a new path and installation of drainage in the Burial Ground.** The Parish Council was only able to obtain one quotation to submit with the grant application to South Oxfordshire District Council, but due to the time lapse, the quotation has expired. The Parish Council is asked to agree that a new quotation should be requested from the contractor to ensure that there are sufficient funds available to proceed with the work.

9. Correspondence and Items for Information.

a) **Neighbourhood Development Plan meeting**. Members are asked to note that the NDP meeting will be held on 9<sup>th</sup> November at 7 p.m. in the Pavilion.

b) **Service of Remembrance**. The Service of Remembrance will be held at the War Memorial at 10.45 a.m. on Sunday 13<sup>th</sup> November. A fly past will take place at approximately 11.07.

c) **Deep Cleanse Service, Berinsfield.** South Oxfordshire District Council will be spending a few days in Berinsfield from  $20^{th}$  to  $22^{nd}$  December 2022 to perform a deep cleanse. They will litter pick, sweep and remove weeds and moss on pavements. They only clear land to which the public is permitted access and that is under the direct control of the District Council.

d) **Lay Avenue Play Area** To receive an update on the installation of the new play equipment.

e) **Hatwells Fair.** A request has been received from Hatwell's fair to hire the recreation ground for the fair in 2023. They would like to arrive on Monday 26<sup>th</sup> June 2023 and leave on 3<sup>rd</sup> July, 2023. The fair would operate on Thursday 29<sup>th</sup> June until Sunday 2<sup>nd</sup> July, inclusive. The Parish Council is asked to consider this request
